This agreement is between: Empower Wholeness LLC. Whereby, Empower Wholeness LLC, CEO, founder and facilitator Elaine J. Lemon (Elayne Le Monde) agrees to provide the Sacred Divine Feminine Rites - Goddess Mystery School Program. The focus of the Transformational Program is to awaken Spiritual Awareness, Soul Embodiment, Transformation, Relationship Balance, Deep Healing, Activations, Sexual Rejuvenation, and Goddess Mentoring. This is a personalized program based off of Elayne's Intuitive gifts and years of study designed to create the experiences and challenge awakening to Soul's purpose and potential.

Description

The Sacred Divine Feminine Rites - Goddess Mystery School is a partnership alliance, between Elayne Le Monde (Elaine J. Lemon), the Client, and other participating students. United we Create a thought-provoking, creative process that inspires the client to maximize personal and professional potential.

Responsibilities

1. Empower Wholeness LLC agrees to maintain the standards of behavior set as per our agreement.
2. Client is responsible for creating and implementing his/her own physical, mental and emotional well-being, decisions, choices, actions and results. As such, the Client agrees that the Empower Wholeness LLC and Elayne Le Monde (Elaine Lemon) is not and will not be liable for any actions or inaction, or for any direct or indirect result of any services provided.
3. Client understands mentoring is not therapy and does not substitute for therapy if needed, and does not prevent, cure, or treat any mental disorder or medical disease. Elayne is not a physician or a psychiatrist, and she will refer client to such as needed. No opinion or advice given by Elayne Le Monde (Elaine J. Lemon) is to be construed as a diagnosis or substitute for medical or emotional professional services.
4. Client understands that mentoring is not to be used as a substitute for professional advice by legal, mental, emotional, medical or other

qualified professionals and will seek independent professional guidance for such matters. If Client is currently under the care of a mental health professional, the Client is fully responsible for any choices they make in the Coaching program that may conflict with the advice of the mental/medical professional. All medications being taken must be disclosed below.

5. Client agrees to communicate honestly, vulnerably, seek deep reflection, and be open to feedback and assistance in order to create the time and energy to participate fully in the program. Homework is part of the program and will be completed before the each session.

Services

The parties agree to engage in a 22 Week On-line mentoring program that is pre-recorded. Each weekly session will last 1 hour. Elayne will be available on a limited basis to Client by e-mail, voicemail, and text in between scheduled meetings as defined for posted answers in a group discussion coordinated through her assistant. Elayne may also be available for additional time, per client's request at an additional rate that is not part of this agreement.

Schedule & Fees

This Sacred Divine Feminine Rites - Goddess Mystery School agreement is valid beginning the day of registration and is available for one year of the time of purchase. The fee is \$2222 for 22 week sessions. Money is payable at the signing of the contract via Venmo, Zelle, direct deposit, website, or other agreed method.

A personal retreat may be added to the Mystery School at additional costs. (Travel expenses not included). Non-refundable deposit and agreement for the remainder balance within will be made within 2 weeks of signing agreement.

The calls shall be 1 hour in length. If rates change before this agreement has been signed and dated, the prevailing rates will apply.

Procedure

The Sacred Divine Feminine Rites will be available weekly on www.EmpowerWholeness.com Mystery School. Additional sessions may be determined by Mentor and Client based on a mutually agreed upon time and price. The Mentor will initiate all scheduled calls on Zoom and a link will be provided. It is the Clients responsibility to participate. All meetings for The Sacred Divine Feminine Rites are pre-recorded.

Confidentiality

This mentoring relationship, as well as all information (documented or verbal) that the Client shares with the Mentor as part of this relationship, is bound to confidentiality, but is not considered a legally confidential relationship (like in Medicine or Law). The Mentor agrees not to disclose any information pertaining to the Client without the Client's written consent. The Mentor will not disclose the Client's name as a reference without the Client's consent. Confidential information does not include information that: (a) was in the Mentor's possession prior to its being furnished by the Client; (b) is generally known to the public or in the Client's industry; (c) is obtained by the Mentor from a third party, without breach of any obligation to the Client; (d) is independently developed by the Mentor without use of or reference to the Client's confidential information; or (e) that the Mentor is required by law to disclose.

Signing this agreement also declares you will support the privacy of other's participating and not disclose other class member's personal sharing.

In addition, all information disclosed in the Sacred Divine Rites - Goddess Mystery School is confidential and shall not be shared publically in any forum unless specifically cleared through Empower Wholeness LLC. The information revealed will be used in future programs and book. Signing this contract releases all information to be shared in future programs without claim of content, identity will not be revealed.

Cancellation and Lateness Policy

Client agrees that it is the Client's responsibility to notify the Mentor at least 24 hours in advance via text of the scheduled call/meeting if the client cannot make the session. Missed session are considered a session if the

client does not reschedule within 24 hours before. Mentor will wait for 15 minutes, before the Client is noted as not turning up for the session.

Termination

Either the Client or the Mentor may terminate this agreement at any time with 2 weeks written notice. This is a non-refundable agreement. Due to the nature of the business, it is necessary to hold space in order to motivate the client throughout difficult periods. Termination does not include a refund.

If a dispute arises out of or relates to this contract, or the alleged breach thereof, and if the dispute is not settled through negotiation, the parties agree first to try in good faith to settle the dispute by mediation within 30 days administered before resorting to arbitration, litigation, or some other dispute resolution procedure. In the event that parties are unable to agree on a mediator, a mediator shall be appointed by the named administrator.

The process shall be confidential based on terms acceptable to the mediator and/or mediation service provider.

Limited Liability

Except as expressly provided in this agreement, the Empower Wholeness LLC makes no guarantees or warranties, express or implied. In no event will the Empower Wholeness LLC be liable to the Client for consequential or special damages. Notwithstanding any damages that the Client may incur, the Mentor's entire liability under this agreement, and the Client's exclusive remedy, will be limited to the amount paid by the Client to the Mentor under this agreement for all services. All sessions and recordings are to be used solely by the Client and sessions are not transferable.

This is the entire agreement of the parties, and reflects a complete understanding of the parties with respect to the subject matter. This agreement supersedes all prior written and oral representations.
